THE FOUR PRIMARY PROGRAMS OFFERED BY THE CRC FOCUS ON RESCUING AND REHABILITATING CHILDREN WHO HAVE BEEN VICTIMS OF CHILD LABOR, AS WELL AS WORKING ALONGSIDE FAMILIES IN THE COMMUNITY TO PREVENT CHILD LABOR BY PROVIDING SUPPORT FOR EDUCATION AND HEALTH CARE. THE CRC ALSO SUPPORTS YOUTH THROUGH POST-SECONDARY EDUCATION SCHOLARSHIPS. THIS PROGRAM ALLOWS HIGH-PERFORMING STUDENTS TO PURSUE EDUCATION AND TECHNICAL TRAINING TO BETTER PREPARE THEM TO MEANINGFULLY CONTRIBUTE TO SOCIETY IN THEIR TRADE OR PROFESSION. IN TOTAL, MORE THAN 450 CHILDREN ARE CURRENTLY ENROLLED IN PROGRAMS OFFERED BY THE CRC.
